PETITION TO SAVE THE HAIKU STAIRS

The Friends of Haiku Stairs was prepared to present a petition to save the Stairs to the Honolulu Board of Water Supply at its regular meeting on August 24th. The petition, which has been signed by 5,514 persons to date, continues to circulate. As this newsletter went to press, no word of the results of this action had yet been made public by either BWS or FHS. Watch the news media for results. PUPUKEA PAUMALU TRAIL WORK CONTINUES

On August 16, under the direction of Tim Tybuszewski, the North Shore Community Land Trust conducted another of its periodic work days to improve the trail from Sunset Beach School to the military pillbox area. Over the past eight months, thanks to the hard work of volunteers, the Trust has installed more than 100 steps along the hiking trail, built a picnic table at a fine lookout over the North Shore, and planted over 200 native plants including Pōhinahina and Koa.

Since the rerouting of the trail, foot traffic from the school to the pillbox has increased dramatically. Any day of the week singles, small groups in flip flops, runners, and families with kids (both in hand and in backpacks), can be seen huffing up the steep section to the new picnic table, or along the contour trail from there to the pillbox.

Meanwhile, the North Shore Trails Association and the Dirt Riders of Pupukea Paumalu continue to build new trails and maintain old ones. Major improvements have been made to *Party Line* Trail, and are under way at *Hula Girl*. Work is concentrating on reinforcing banked curves and clearing obstacles from pathways. New, more permanent signs are being installed on many of the major trails, high enough to prevent vandalism. NSTA/DROPP members have also expanded the picnic/rest area at "Lilikoi Junction," which now boasts three picnic tables, benches, a hitching post, and additional plantings, including palms, avocado, and citrus trees

Although the interior portion of the park reserve remains primarily the domain of mountain bike riders, an increasing number of hikers are exploring deeper into its mauka sections. The HTMC and Solemates schedule annual hikes "from the mountains to the sea," following the route pioneered by HTMC which connects the Kaunala Trail to Sunset Beach School.

Arnold, entrusted with the defense of West Point during the Revolutionary War, attempted to surrender it to the British. Warned of the plot's failure, he escaped to British lines.
